 - a. NHS Supply Chain framework

The scanned version of this document provided as a PDF does seem like a genuine novation of contract in 2019 but SCCL would need to see the original signed copy to validate this.

b. Blood Collection framework

The scanned version of this document provided as a PDF does not seem like a valid agreement. NHS Supply Chain was not operated by DHL Supply Chain in 2020 as SCCL, the management function of NHS Supply Chain became fully operational in 2018. The document also states the framework was being extended to 2027, which is inaccurate.

6. Please confirm if the highlighted payments on the attached bank statements from NatWest bank S/C 60-24-77 A/C 25404598 made from NHS to Matz Medical limited are true reflection?

We are not obliged, under section 40(2) of the Act, to provide information that is the personal information of another person if releasing would contravene any of the provisions in the Data Protection Act 1998 (DPA).
