- What services are included in the contract(s)? As 'Prime' IT provider, DXC were contracted to provide all supporting technologies and infrastructure services to SCCL.
- 2. The contract start date? 14 August 2018.
- The contract end date?
 13 August 2024. A Termination Assistance Agreement, provided for under the original contract, was entered into for a period of 24 months from August 2024.
- 4. The total award value of this contract? £248,800,000.
- 5. The actual spend through this contract?

We hold the information which you have requested but we have estimated that the cost of meeting your request would exceed the cost limit of £450 specified in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004. We are therefore unable to comply with it. Contract spend for the original term was broadly in line with original expectations, we have not provided an exact figure and estimate the cost of locating, retrieving and extracting information will exceed the cost limit. The £450 limit is based on work being carried out at a rate of £25 per hour, which equates to 18 hours of work per request.

6. Are you planning to reporcure or disaggregate the services in this contract? A programme to disaggregate the services under the contract and re-procure is currently underway. Service Integrator and Cyber services contracts having been awarded, with remaining procurements currently in-flight.
